This is an agreement for all group classes and private lessons held by HomeGrown DogSports. All fees payable by cash or check to Sally Zinkhan. The classes will be held at 15202 Carroll Rd. , Monkton, MD 21111. In the event that we need to cancel classes due to the weather or other circumstance, you will be notified by email/Twitter/Facebook. It is your responsibility to check to see if classes are canceled. If we must cancel a class the course will run for an extra week to make up for the class missed. Cash or checks reserve your spot in the class which is limited to 4-6 participants on a first come first serve basis. No refunds will be given after the beginning of the first class unless a note from your veterinarian of your dog's physical inability to attend the class is submitted.

MAKE UP CLASSES - No refunds, credits, or free make up's will be given for missed classes. Two or more missed classes may excuse you from attending any further classes. NO DISCOUNTS will be given for classes you miss or know you will miss in the session. THE ONLY EXCEPTION TO THIS RULE: IF YOU MISS A CLASS BECAUSE IT CONFLICTS WITH A COMPETITION THAT YOU ARE ENTERED IN WITH YOUR DOG THAT DAY. ABSOLUTELY NO EXCEPTIONS.

SERVICES PROVIDED: Classes are taught by Sally Zinkhan/HomeGrown DogSports, et al. professional dog trainers. Instructor, at her discretion, may refuse entry to a pet which is not healthy, is aggressive or does not seem suitable for a group class.

REMOVAL FROM TRAINING: Instructor, at her sole discretion, may remove a pet from class if a hazard or threat of any nature to any other animal or person is present. Should this occur, no refunds will be given.

LIABILITY: Owner agrees to indemnify and hold owner and renter of 15202 Carroll Rd. , Monkton, MD 21111 ("Location") and Instructor harmless from all liability for any loss, damage or injury to persons, animals or property arising from or related to Owner's pet. Owner agrees that Location and/or Instructor shall not be liable for loss or damage to animal (guests and or children) for any reason unless said loss or damage was a direct result of Location or Instructor's negligence.

ARBITRATION: Any controversy between the parties involving any of the terms, covenants, or conditions of this Agreement shall be submitted to arbitration in Baltimore County, Maryland, on the request of any party, and shall comply with and be governed by the provisions of the American Arbitration Association. All decisions shall be final and binding. In any dispute between the parties, whether or not resulting in litigation, the party substantially prevailing shall be entitled to recover from the other party all reasonable costs, including without limitation, attorney's fees.
